Directions for Nominations

NOMINATION FORM (Form J Front)

1. The Nomination Form must be completed by filling in ***all*** blanks on the form including information on nominators.
2. The form must be signed by 10 electors who live in the subdivision for which they are nominating an individual.
3. Only one person shall be nominated on each nomination paper.
4. A candidate is not allowed to nominate them self.
5. Voters may sign the nomination paper of more than one candidate.
6. No person can be nominated in more than one sub-division.
7. The onus to file a bona fide nomination paper is on the person being nominated.

CANDIDATE'S ACCEPTANCE FORM (Form J Back)

1. The Acceptance Form must be completed by filling in ***all*** blanks on the form.
2. The candidate must sign the form in front of 2 witnesses who sign as indicated.
3. Witnesses are not required to be eligible voters in the school board election.

CANDIDATE CONTACT INFORMATION FORM

1. Information will be used only by school division personnel to contact the candidate. This form and the information it contains will be kept confidential.

NOTE: The Nomination Form and Candidates Acceptance Form are public documents

All 3 of the above forms are to be submitted by one of the following methods:
